Tournament Format - emphasis is on fun!

Teams and Players

The team shall be made up of 7 players (max 11 players per team) with unlimited substitutes. Minimum of 5 players per team on the pitch. The team shall be of mixed gender, and family members of corporate entity personnel. Please note there will be an age restriction and all players must be over the age of 11 to participate. Each team has maximum of 7 payers at any time, but shall be inclusive of minimum of 2 players from the following categories ON THE FIELD AT ALL TIMES:

- Females, or
- Males over 45 years of age, or
- Children below 15 years of age.

Teams failing to meet the above requirements shall take players off the pitch and play short.

Rules

Referees to be provided. Rules will be as per FIFA (including throw ins) except:

- Halves to consist of 9 minutes, with 2 min. half time break (finals are 10 min with 2 min ½ time break)
- Unlimited substitutes (during break in play only)
- No off-side
- No slide tackles
- Players on field as per above
- Ball from goalkeeper's **hand** cannot be kicked or thrown over half way on full, otherwise free kick at half way. Kicking from ground over ½ way is allowable.

Referees will keep the score and hand scores in, but it is up to captains to make check at completion of match with the official.

For Yellow Cards there is an on the spot fine of \$20, Red Cards \$50 (3 yellow cards accumulated -1 match suspension). Swearing around ground = \$25 fine. To be paid to desk, before commencement of next match.

Should two teams end up with equal points after the pool play then goal difference will be calculated, followed by goals for, number of free kicks / for / against, as being the tie breakers. For final series, halves are 10 minutes. If there is a draw in the final series, one player to be taken off the pitch from both sides every 1 minute until a score (golden goal). If scores are still even at end of extra 3 minutes, then penalty kicks will apply (best of 3).

Team members are to wear the same uniform (numbers are not necessary). **Shin pads are compulsory**. No metal studs on boots. Jewellery to be removed.



Uniform and playing aspects

Teams to nominate strip colour (+ spare) and supply 2 balls (size 5). The designated goalkeeper shall be of different colour shirt to other players. Teams will appoint a captain who will represent / manage the team.

Other Activities / aspects

There will be entertainment for children and full catering on the day. For those not participating in football/soccer there will be a charge for food and soft drinks. Full bar service AND coffee available at canteen. To further support WaterAid please buy coffee, soft/sports drinks from canteen rather than bring your own.
